Central Asian International Textile Machinery Exhibition (CAITME 2009) is the largest international Textile Machinery Exhibition in Central Asia.

### **Potential of Textile Industry in Uzbekistan**

The Textile Industry in Uzbekistan is being considered as one of the most strategic and dynamically developing sectors of local economy with numerous quantitative and qualitative changes. Economic performance of the industry has seen a significant increase in the volume of domestic processing of cotton fibre, exports and production rates. Thus only in 2007 the volume of industrial production has grown by over 50%, the volume of exports of the industry has grown by 40% comparing to the year 2006. The share of finished textile products in the total volume of exports has increased up to 20%. In 2007 the volume of capital investments to the industry comprised over UZS 109 billion, including USD 82.5 million of foreign investments, 23 new joint ventures started to operate and export their products to the foreign markets.

With the purpose of further development of the textile industry it is also expected to conduct a modernization and reconstruction of all obsolete enterprises while establishing new ones with the complete cycle of production, up to finished goods with high value addition, resulting into surge in demand for modern high quality equipment and technologies of world's best manufacturers at a competitive rates.

Participation in CAITME 2009 will not only provide a successful entry into the Uzbekistan, but also other neighbouring countries of the Central Asian region, such as Kazakhstan, Kyrgyzstan, Tajikistan and Turkmenistan, the vast and booming new textile region of the world.

All eligible participants will be entitled to MDA grant under Focus CIS Programme of Ministry of Commerce, Government of India as per the MDA Guidelines effective from April 01, 2006.

Assistance would be permissible on travel expenses by Air in Economy Excursion Class fare and/or charges of built up furnished stall subject to an upper ceiling of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand only).

Further, eligibility for MDA grant is subject to exporting companies having FOB value of exports up to

Rs. 15 crores in the preceding year, having complete 12 months membership with EEPC India with regular filing of returns and fulfilling other conditions, details of which can be obtained from respective Regional Offices of EEPC India.
