EEPC India Invites Participation for India Pavilion at JIMEX 2012, Amman, Jordan (4 -7 June 2012)

JIMEX 2012 is the 9th International Machinery & Electro-mechanical Exhibition held in Amman, Jordan. The Exhibition is organised by Golden Gate and Jordan Engineers Association. The exhibition will be focusing on Machinery, Electricity, HVAC & Water Technology, Energy, Renewable Energy and Industrial Supplies.

Amman is also the gateway to nearby markets like Syria, Iraq, Palestine and others because of Jordan's strategic location, open relationships with neighbouring countries and business friendly laws for foreign investors. Jordan is very attractive for foreign investments. Due to many reasons such as safety, political stability and its central location in the Middle East.

JIMEX 2012 will have more than 7000 professional and trade visitors. The attendants are professionals, trade visitors, experts, decision makers, businessmen, directors and officials mainly from industrial, trading firms, water and electrical utilities, contracting and consultancy companies, social organizations and institutes. Visitors are expected from countries including Jordan, Palestine, Syria, Iraq, Lebanon, Turkey, Gulf Countries, Egypt, Europe, India, China, and South Korea.

In order to reach full potential for economic and social development, the Jordanian government has focused on developing the Industrial sector, it provides the majority of new jobs and produce much of the creativity and innovation that fuels economic progress. The main industrial sectors of Jordan – Manufacturing and Mining contribute 18% and 2% respectively of GDP.

This shows that there is a great potential to tap the growing market. Indian engineering exports to Jordan stood at US\$ 58.15 million in 2010-11, an increase of 50.14% compared to US\$ 38.73 million engineering exports from India to Jordan in 2009-10.

Assistance would be permissible on charges of built up furnished stall subject to an upper ceiling of Rs. 80,000/- (Rupees Eighty Thousand only).

Further, eligibility for MDA grant is subject to exporting companies having FOB value of exports up to Rs. 15 crores in the preceding year, having complete 12 months membership with EEPC India with regular filing of returns and fulfilling other conditions, details of which can be obtained from respective Regional Offices of EEPC India.
