EEPC India Invites Participation for India Pavilion at Practical World International Hardware Fair 2012 Cologne, Germany (4 - 7 March, 2012)

Practical World International Hardware Fair is one of the major international exhibitions on hardware industry covering sectors like Tools, Industrial Supply, Locks & Fittings, Fasteners & Fittings. It is organized by Koelnmesse GmbH. It takes place every two years, corresponding to the innovation cycle within the sector.
