**Sub : National Award (Government of India) for
Outstanding Export Performance during 2004-2005 (38th Set)**

Under the Scheme of 38th Set of Award for Public Recognition of outstanding export performance during April 2004 to March 2005, the Council has been advised by the Government of India to sponsor applications of its members, exporting engineering goods for the above Award. Accordingly members who are interested in the 38th Set of Government of India Award and also fulfill the criteria, are hereby requested to submit their applications in the prescribed Application Form in duplicate as per *Annexure - II* of this Circular along with Auditor's Certificate in support of their performance data **so as to reach the Head Office of the Council, Kolkata positively latest by 2nd December, 2005** to enable the Council to forward the suitable applications to the DGCI&S, 1 Council House Street, Kolkata for their consideration.

Details about 38th Set of Awards for Trophies (Shields) and Certificate of Merits are reproduced below :

TROPHIES (SHIELDS)

Awards (maximum 20 Nos.) in the form of Trophies may be given to Manufacturers, Exporters, Export Houses, Trading Houses and Star Trading Houses who make a distinct contribution to export trade. Up to 8 (Eight) Awards out of the total 20 Awards will be given to the exporters from Small-Scale and Cottage sector subject to availability of suitable and sufficient number of applications from this sector. There will be no reservation of Awards for any specific line on export (say for Engineering, Chemical, etc.).

CERTIFICATES OF MERIT

In addition to the Awards referred to above, Certificates of Merit will be granted to the best exporters in the different groups of export products, from amongst the registered members of respective Export Promotion Councils.

Our Council has been authorized to sponsor applications for following product groups :

CATEGORY - 4

Engineering & Metallurgical Products

Group XXVII	Prime and Semi-Finished Iron & Steel.
Group XXVIII	Metal Manufactures.
Group XXIX	Machineries and Equipment thereof.
Group XXX	Light Engineering Goods.
Group XXXI	Transport Equipment.

CRITERIA FOR SELECTION

Eligibility for the Awards shall be based on the following consideration :

- (i) Growth in exports during the year over the preceding year should not be less than 50% for Award of Trophy (Shield). For Award of Certificate, it is relaxable to 40%.
- (ii) Compound growth in exports over the period of 3 years should not be less than 40% both for Trophy (Shield) and Certificates.

A formula for calculating the compound growth is given below :

$$A = P (1 + r/100)^n$$

Where A = Export in the final year 2004-2005
P = Export for the base year 2002-2003
r = Rate of growth
n = No. of years.

- (iii) In order to qualify, exporters should have some exports to his credit during all the preceding 3 years.
- (iv) If the percentage growth condition of (i) & (ii) is not satisfied, the minimum absolute growth in exports should not be less than Rs. 5 crores for small-scale industries and Rs. 10 crores for non-small scale sector during 2004-2005 as compared to 2003-2004 both for Trophy and Certificate. However in case there is a negative growth during 2003-2004 then this condition of growth shall apply with reference to the year 2002-2003.

The same is explained as under :

- (v) Minimum exports during the year should be Rs. 2 crores for SSI and Rs. 6 crores for Non-SSI for Award of Trophy (Shield). For Award of Certificate, it is relaxable to Rs. 1 crore for SSI and Rs. 4 crores for Non-SSI.

Members of the Council having outstanding export performance in 2004-2005 and also fulfill the eligibility condition as mentioned above may apply for any of the Awards referred to above viz. (i) Trophy (Shield) and (ii) Certificate of Merit. They should submit their application to the Council's Head Office, Kolkata in the prescribed Form as per **Annexure - II**.

It may please be noted that the Council is just the sponsoring agency. Final selection of Award winners will be made by a Selection Committee appointed by the Government of India and the Government decision is directly communicated to the respective applicant and not through the Council.

It may be noted that National Award is totally different than that of the Council's Export Award and as such members interested in National Award are to submit their application as per Proforma enclosed with this Scheme, filled in with complete details by typed scripts, duly signed by the authorized signatory and accompanied by Auditor's Certificate in respect of export and other performance for all the 3 years **without which no application will be entertained for nomination**.

Annexure - I

Instruction for filling up Proforma

- All entries are required to be filled in by typed scripts.
- Only one Application Form is to be filled up by the nominee which will be considered for Award of Trophy (Shield) as well as Certificate of Merit on the basis of criteria fulfilled.
- No entry should be kept blank, if a column is not applicable or information is not available then mention clearly 'not applicable' or Nil.
- Answer should be specific for each query.
- Each nomination should be sent to DGCI&S, 1, Council House Street, Kolkata through the authorized sponsoring authority.
- Each nomination should be accompanied with necessary Audited Certificate in support of claims of export made during all the three years.
- Commodity codes as per ITC (HS) should be given for each commodity exported.
- All entries in the detailed form should be consistent with the information furnished in summary form.
- No nomination will be considered unless the forms are properly signed with date and office stamp.
- Any application not conforming to the above mentioned instructions is liable to be rejected.
