

## INDIA PAVILION AT ITMA ASIA 2005, SINGAPORE (17 - 21 October, 2005)

**ITMA ASIA 2005** - the Second Asian International Exhibition of Textile Machinery is scheduled to be held from 17th to 21st October, 2005 at Singapore. Engineering Export Promotion Council (EEPC) is organizing an "India Pavilion" which would provide an excellent opportunity for new business relationships with customers from all over the world. ### Focus Exhibits

- Machinery for spinning preparation, man-made fibre production, spinning, winding, texturing, twisting, auxiliary machinery and accessories.
- Machinery for web formation, bonding and finishing of non-wovens and felting and accessories.
- Weaving preparatory machinery, weaving, tufting machinery, auxiliary machinery and accessories.
- Knitting and hosiery machinery, auxiliary machinery and accessories.
- Washing, bleaching, dyeing, printing, drying, finishing and make-up machinery, auxiliary machinery and accessories.
- Other machinery and other accessories.
- Machinery for making-up industry and accessories.
- Testing and measuring equipment.
- Pneumatic equipment and air conditioning plants.
- Transport, handling and packing equipment.
- Equipment for liquid, solid and air recycling.
- Software for design, data monitoring, and processing (CAD/CAM/CIM) and integrated production.
- Technical information sources/educational institutions.
- Dyestuffs and chemical products for the textile industry.

### Participation Charges

Rs. 18,000/- per sq. mtr.

- A minimum of 15 sq. mtrs. or multiples thereof has to be booked
- For stalls with open sides, additional charges ranging from 10% to 50% would be required to be paid depending on size and type. Details are available with all Regional Offices of the Council.

The participation charges would include the following services as per Clause A 11 (General Regulations) of the ITMA ASIA 2005 organizers :

- Handling of the exhibits from their arrival at the Singapore Expo to the time they are delivered to the stand including the placing of machinery on the stand in accordance with the exhibitors stand layout. After the exhibition, the handling of the exhibits from the stand to the exhibitors transport within Singapore Expo
- Provision for cranes, forklift trucks or other hoisting equipment for the assembly and dismantling of exhibits on the exhibition site
- Forwarding agents charges for exhibits arrival and departure operations
- Fees for customs clearance only for shipments consigned to the official onsite forwarding agents
- Insurance of exhibits and stand fitting materials against normal exhibition risks as defined by the insurance policy carried by the exhibitor, including fire risks and third party liability
- Provision of a main isolator for lighting and machinery power connections
- Electricity/Water
- Company sign and demarcation of stand boundaries
- Conveyance and storage of exhibits empty packing materials
- Conveyance and storage of auxiliary devices and materials, as well as all materials required for and produced by demonstrations

- Removal of waste material and products
- Promotional materials : stickers, posters, pamphlets
- Entry in the exhibition catalogue
- Exhibitors passes
- Parking passes

### Mode of Payment

Full payment is to be made along with Application Form - duly filled in, **latest by 30th June, 2005**. Payment must be made by Demand Draft drawn in favour of **Engineering Export Promotion Council**, payable at **Kolkata**.

### Cancellation of Participation

Requests for cancellation of participation will be accepted if the Council receives the same in writing on or **before 10th July, 2005**. Any request for cancellation after the said date shall result in forfeiture of the amount already paid on this account.

### Selection Criteria

In view of limitations of space availability, selection of participants will be done strictly on *first-come-first served* basis.

### MDA Entitlement

Participants are entitled for MDA Assistance as per the guidelines effective. Grant is available on a certain percentage as ceiling for stall charges and the air-fare of the participant.
