INDO-AUSTRALASIA REVERSE BSM - 2005

EEPC, during 2000-01, launched an Integrated Market Access Plan for Australasian countries, under MAI programme of the Ministry of Commerce, which entailed contact promotion with buyers, dissemination of market information to Indian exporters, and physical exposure of Indian products and technology through INDIA TECH expositions in Melbourne, AUSTRALIA in 2002.

These activities have created significant awareness amongst trade and industrial community both in this region as well as in India about the prospects of trade and industrial cooperation for mutual interest. This is evident from growing interest amongst the Indian trade about the Council's activities and flow of enquiries from this region for procurement from India as also cooperation in the form of joint venture tie-ups.

Keeping in view the growing awareness of trade prospects and genuine interest on the part of the buyers to further contacts with Indian exporters of engineering goods, Council has decided to hold a **Reverse Buyer-Seller Meet** between Indian exporters and importers of these countries in February 2005 at Chennai, Delhi and Mumbai as indicated above. For this Reverse Buyer-Seller Meet the Council is mobilizing 40 buyers from Australia, New Zealand & Papua New Guinea.

Products identified as having potential for Business Meet include **Steel Pipes & Tubes, Aluminium and Products thereof, Copper and Products thereof, Electric Power Equipment & Parts, Auto Components, Industrial Machinery, Ferrous Hollowware, Chemical Plant & Machinery, Heating & Cooling Equipment, Machine Tools, I. C. Engines & Parts, Construction Machinery, Mechanical Pumps, Food Processing Machinery, Sanitary & Industrial Castings, Scientific Surgical Instruments, Electrical Home Appliances, Razor Blades, Hand, Small & Cutting Tools, Industrial Fasteners etc.**

Depending on your choices, meetings will be fixed with overseas delegates. Each exporter will be provided with **minimum of 3 meetings**. Each meeting will be of 20 minutes duration. Final match making will be done keeping in view the areas of matching interest of both sides and choices thereof. Council will, thereafter draw up time schedule for interaction between overseas delegates and Indian participants. Meeting schedule of each Indian Company will be forwarded to them in advance.

The Participation fee (for one centre only) has been fixed as follows :

Rs. 15,000/- for 1st participant of a firm;

Rs. 7,000/- for subsequent participants of the firm.

The participation charges will partially cover the expenses on account of portfolio bag containing background paper and bio-data profiles of overseas delegates and lunches on Conference days. This will also cover expenses on overseas delegates.

Council will reserve the right to accept or reject participation of an Indian company.

Last date for enlistment of participation is 30th January, 2005. Participation will be confirmed only after final matchmaking and on first-come-first served basis.
