Home Pages Hosting/Hyperlinking Services on Council's Website

As you are aware, Council is having its own website www.eepc.gov.in (EEPCNet) on Internet URL. The visitors to our site are not only accessing general pages but also the home pages of member-exporters hosted on EEPCNet. We would like to further inform you that now we have redesigned our website and the same is available in Spanish and Portuguese languages also so that communication with Latin American buyers will be more easy which will assist in increasing the information level about Indian products and Indian companies.

Following are the benefits in availing Home Pages Hosting/Hyperlinking Services

1. Your company will have an opportunity to be listed on India's only website exclusively on Engineering Sector.
2. EEPC, being a Government Sponsored Organisation and India's first ISO-9001 Council, overseas buyers, while surfing Internet, will have more confidence in doing business interactions with Council's members who have hosted their home pages/hyperlinking on Council's website.
3. Your company may get on-line business enquiries of overseas buyers generated through Council's website.
4. Council has also designed its website in Spanish and Portuguese languages so that maximum number of importing community from Latin America region can do business interactions with Indian exporting community. Soon, the website will be in other popular languages also.

Apart from hosting of home pages of exporters, the website also carries various useful information like Public Notices, Circulars & Notifications issued by DGFT, Customs and Central Excise.

If interested, please fill-up the enclosed Application Form duly signed and stamped (given overleaf) along with Terms & Conditions duly signed and stamped (given below) as well as DD/Cheque of Rs. 1,500/- for members and Rs. 2,500/- for non-members and text matter of your web page (duly signed and stamped).

Terms & Conditions for Hosting of Home Page/Establishing Link through EEPCNet

1. This facility shall be made available to the exporting community.
2. Any engineering firm can apply to the Council to avail of the services by making an application on this Form (given overleaf).
3. **The prescribed service charges (i.e. Rs. 1,500/- per annum) shall be payable in advance for EEPC registered members only. In the case of non-members, the charges would be Rs. 2,500/- per annum.**
4. The charges shall be for one year duration starts from the date of hosting of the home page on Council's website. A subscriber joining any part of the year shall have to pay the service charges for the full year and not part thereof.
5. Before providing the Hyperlinking OR Hosting of home pages services, the In-charge, TID shall visit the website of the exporting firm to find out if the contents are suitable.
6. Connections will be provided if only the contents of the home pages of exporting firm are found suitable.
7. If the subscriber desires to change the contents of the web page/website any time during the service period, she/he shall intimate the Council beforehand, in writing. The member shall have to pay the applicable charges to accommodate the modifications.
8. For hosting the web page on EEPCNet, the subscriber shall have to provide the matter on *html format* on a 1.44 floppy disc. Maximum size of the contents should not exceed 1.4 MB.
9. If the subscriber desires to discontinue the service any time of the year no refund shall be made by the Council for the balance period.
10. While the Council shall provide the service to the subscriber on continuous basis but in the eventuality of the technical snag/telecommunication failures, if the availability of the service is suffered, the Council shall not be responsible to provide any compensation whatsoever.
11. Disclaimer : The Council may at its discretion display a Disclaimer clause on its net the Council shall not be responsible and/or hold no guarantee over the accuracy, reliability, completeness or the usefulness of the data included in the home page of the member hosted on EEPCNet.
