**Colombia : One of the fastest growing Latin American economies**

Colombia is the **fifth largest country and the fourth largest economy** in Latin America. Colombia's industrialized economy benefits from diverse **agricultural and natural resources**.

The increased security combined with sound fiscal practices has allowed Colombia to become **one of the more stable economies in the region**. Moderate inflation of 7.6 percent in 2009 and a relatively stable political environment compared to **neighbouring Andean countries make Colombia attractive as a business partner of future**.

**Colombia imported about US\$ 14049.86 million worth of engineering goods in 2009**. India's exports of engineering goods to Colombia were to the tune of US\$ 120.53 million in 2009, down from US\$ 151.51 million in 2008. In 2009, India's share in global engineering imports by Colombia was about 0.86%.

**Colombia's global imports of engineering goods have grown at an average rate of over 25%** till 2008. The year 2009 saw a southward movement following global recession.

Colombia is **a member of Andean Community**, the other members being Bolivia, Ecuador and Peru. Argentina, Brazil, Paraguay, Uruguay and Peru are the associate members.

**Why Bogotá?**

**Bogotá is the main economic and industrial center of Colombia**. In 2008 the city ranked as the fourth most influential financial center of Latin America. In the period 2003-2006, its commercial GDP grew by 10.3% annually, accounting for 25.3% of GDP national trade.

**The city is one of the largest industrial centers in Latin America**. Of the 248,000 companies in Bogotá, 78% are linked to service activities, contributing to 76% employment and 79% of GDP. The highest concentrations of industrial establishments are in Puente Aranda, Fontibón, Kennedy, Martyrs, and Barrios Unidos Engativá (in that order). Important businesses include the food industries, chemical, pharmaceutical, textile, publishing and metalworking. The city exports mainly agricultural products (30%), chemicals (10%) and textiles (7%), and imports transportation materials (17%), machinery except electrical (17%) and electrical machinery (14%).

Two sides open booth (Built up booth)	: US\$ 345 per sq. mtr. or Indian Rs. 16,500/- per sq. mtr. + Rs. 1,700/- per sq. mtr. as Service Tax.
Bare space <b>(Minimum 36 sq. mtr.)</b>	: US\$ 230 per sq. mtr. or Indian Rs. 11,000/- per sq. mtr. + Rs. 1,133/- per sq. mtr. as Service Tax.

**If participants make payments in US dollars, then Service Tax is not applicable.**

Due to limited availability of corner booths, allocation will be done on first-come, first-served basis subject to receiving full payment.

### Payment & Cancellation

Full payment should be made along with **Application Form**, duly filled-in latest by **31st August, 2010**. The payment should be made by way of **Demand Draft** drawn in favour of "**EEPC India**".

Booking of space will be considered only after receiving 100% payment. Any cancellation after confirmation would result in 100% forfeiture. Acceptance of application and allocation of space will be at the sole discretion of EEPC India.

### Selection Criteria

Final selection of the participants will be done by a Committee based on the criteria such as Accreditation to the International Standards (like ISO, QS, etc.), foreign collaboration, annual exports etc.

### Shipment of Exhibits

In order to facilitate shipment of exhibits, EEPC India will appoint a Shipping Agent. However, the participants are free to choose their own shipping agents.

### Travel and Hotel Accommodation

EEPC India will assist participants in locating suitable airlines and hotels at Bogotá, Colombia at negotiated rates through accredited Travel Agents. However, participants are free to make their own travel/hotel arrangements.

### Visa



EEPC India will issue recommendation letters in favour of the representatives of the participating Indian companies in INDEE for issuance of visa for the show. However, EEPC India will not give any guarantee to this effect, as this is the sole discretion of the Embassy of Colombia in India.

*EEPC India will recommend for issuance of visas for a maximum number of two participants for each 9 sq. mtr. booth.*

### **MDA Grant**

All eligible participants will be entitled to MDA grant under Focus LAC Programme of the Ministry of Commerce & Industry, Government of India as per the MDA Guidelines effective from April 01, 2006. The MDA guidelines can also be downloaded from <http://commerce.nic.in/mda-guidelines.pdf>

Assistance would be permissible on travel expenses by Air on return Economy Excursion Class fare and charges of built-up furnished stall subject to an upper ceiling of **Rs. 1,80,000/- (Rupees One Lakh Eighty Thousand only)**.

Further, eligibility for MDA grant is subject to exporting companies having FOB value of exports not exceeding Rs. 15 crores in the preceding year, having completed 12 month membership with EEPC India with regular filing of returns and fulfilling other conditions, details of which can be obtained from respective Regional Offices of EEPC India.
