This has been the second consecutive year of improvement for the country given that last year India improved its ranking by 30 places, a remarkable feat for the country. As per the World Bank Doing Business Report, 2019 South Asia region made maximum improvement in terms of Ease of Doing Business score with highest average number of reforms per reforming economy. In total 19 reforms were implemented by five of the eight economies in the region making last year second best year for doing business in the region in the last 16 years of Doing Business Survey (Doing Business 2018 recorded 21 reforms). India and Afganisthan featured among the top 10 economies showing most notable improvements in performance on the Doing Business indicators with significant regulatory reforms in the areas of starting a business and getting credit.

The areas in which the region performed best included *Protecting Minority Investors* (average rank of 64) and *Starting Business* (101). While the global average of *Starting Business* is 20 days, in South Asia it has been lowered to 14 days. In terms of *Protecting Minority Investor*, India ranked among the top 10 nations globally. The major areas where the region underperformed included *Registering Property* (average rank of 144),



Enforcing Contract (average rank of 145) and Paying Taxes (average rank of 132). Registering property in the region may take 114 days while the global average is 47 days.

Country-wise, India remained the topmost improver in the region for the second consecutive year with six reforms closely followed by Afganisthan which brought in five reforms. Afganisthan also recorded maximum improvement globally. Also, India, Bhutan, Sri Lanka and Afganisthan substantially streamlined the process of paying taxes. Few other areas where South Asian economies recorded major improvements are given below

Afganisthan: The country strengthened minority investor protection by encouraging greater disclosure of transactions between interested parties easing shareholder suits by extending access to documents and evidence during trial. It also increased shareholders' rights and role in major corporate decisions, clarifying ownership and control structures and requiring greater corporate transparency.

India: Implemented various initiatives such as electronic sealing of containers, upgrading of port infrastructure and electronic submission of several important documents which have substantially reduced the time and cost of trade.

Pakistan: Implemented online one stop registration system by replacing documentation issues with a single online application and also established information exchange between registry and tax authority. This has made *Starting Business* easier in the country.

Sri Lanka: made dealing with construction permits more streamlined and less time consuming by launching a single window counter and improving the efficiency of obtaining certificates required to undertake a construction project.


During May 2019, engineering exports to South Asia declined by 9.9% over May 2018. Increase in exports was witnessed in case of only Pakistan (31.8%) and Bangladesh (3.8%). While Nepal remained in the topmost position in terms of volume of exports, there was a decline of 17.2% between May 2018 and May 2019. Other notable countries which experienced significant decline included Sri Lanka (-20.6%) and Bhutan (-37.6%).

In cumulative terms too between April-May 2018-19 and April-May 2019-20, India's overall exports to South Asia declined by 5.7%. In cumulative terms too, Nepal remained the topmost export destination in the region in terms of volume. However, there was a decline in exports by 13.3% between April-May 2018-19 and April-May 2019-20. Increase in exports were witnessed in case of Bangladesh, Pakistan and Afganisthan while exports to Sri Lanka and Bhutan experienced decline.



Product group-wise analysis of Indian engineering exports to South Asia showed that 'Iron and Steel' remained the highest exported engineering product group to South Asia in May 2019, however, the exports declined between May 2018 and May 2019 by 1.4%. Among the top 10 panels, maximum y-o-y increase was evident in Aluminium and its products (35.9%) followed by Products of iron and steel (16.4%), Motor Vehicles and cars



(16.3%) and Auto components and parts (12.2%). Substantial decline was evident in Ships boats and floating structures (-51.3%), Industrial machinery (-17.1%), Electrical machinery and equipment (-9.2%).

In cumulative terms too, iron and steel remained the highest exported engineering product in April-May 2019-20 though there was a decline of 21.9% between April-May 2018-19 and April-May 2019-20. Substantial rise was witnessed in Ships, boats and floating structures, two and three wheelers and Motor vehicles and cars. Barring Iron and steel, Electrical machinery and equipment, Industrial machinery and Other construction machinery also experienced decline.



Major Importers of India's engineering products to South Asia during April-May 2019-20

Nepal: Nepal was the largest destination for Indian engineering products among all South Asian nations during April 2019 with around 38.8% share.

Top exported Products: Iron and Steel, Motor Vehicle/cars, Other Construction Machinery, Industrial Machinery, Two and Three Wheelers.

Bangladesh: Second largest importer of Indian engineering products among all South Asian nations during April 2019 with over 38.2% share.

Top exported Products: Iron and steel, Motor Vehicle/Cars, Industrial Machinery, Two & three wheelers and Other construction machinery.

Sri Lanka: Sri Lanka was the third largest export destination for India's engineering exports in the South Asian region during April 2019 with a share of 13.4%.



Top exported Products: Two and Three Wheelers, Industrial Machinery, Motor Vehicle/cars, Ships Boats and Floating Structure and Products of Iron and Steel.

Anti-dumping measures

- At present, no anti-dumping case on Engineering product being investigated by Nepal, Bangladesh or Sri Lanka, the top three importers of Indian engineering products in South Asian region, against India as per the WTO website.
- On the other hand the WTO website shows no anti-dumping case is being investigated by India at present on imports of engineering products from those three nations.

India's Experiment with Sub-Regional Initiatives - Analysis

As SAARC frequently ceased to be a regional platform to foster regional trade and connectivity being a victim to Indo-Pak standoff, India led efforts at launching sub-regional initiatives such as Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC) in 1997 comprising members such as Bangladesh, Bhutan, India, Myanmar, Nepal, Sri Lanka and Thailand, BCIM initiative in 1999 to establish an economic corridor between Bangladesh, China, India and Myanmar and BBIN initiative in 1997 between Bangladesh, Bhutan, India and Nepal with the objectives of forging cooperation on connectivity of power, transport and infrastructure.
