The members are requested to submit following documents along with the application form:

1. Application form duly filled up and certified by a Chartered Accountant. **Please note that Export figures in the Application has to be provided in Rs. Crores.**
2. IEC Certificate showing PAN;
3. Registration-cum-Membership Certificate of EEPC;
4. To substantiate classification as Micro, Small and Medium Enterprises, the applicants are mandatorily required to submit one or more relevant pages of balance sheet with details of investment in plant and machinery as on 31st March 2020 duly certified by a Chartered Accountant. For this, the candidate has to submit individual unit wise investment in Plant and Machinery (Gross Block) for the year

2019-20. No certificate regarding MSME/SSI/or Certificate from Directorate of Industries will be considered as valid without above pages of balance sheet and in that case the Award Application will be considered as incomplete and liable to be rejected.

5. A No-Objection Certificate in case the applicant had made some exports through other organization i.e. in case of Indirect Exports. Here the No-Objection certificate will certify that the final exporter has no objection if the applicant gets any award for his outstanding export performance.

N.B :

- In the event, of any Award offered to any Exporter is found to be in appropriate, Award Committee will decide for corrective action. In the reverse case that is if the Award Application is found to be incorrect after the award is offered, Award Committee may request for withdrawal and return the same Award to its Regional or Head Office as per their convenience.
- The Award Applications will be sent to the Regional Offices for selection of Award Winners at the Regional Level for the same year as considered for All India Level.

Award for participation in promotional activities would be given away based on the points scored by applicants. The points have been given in the Scheme against types of activities organized by the Council. Panel wise awards have been done away with in the new scheme, and 105 product-specific awards will be given away in the Star Performer category.
